Christ Church South Cambs has asked if they can use Orchard Park to run another Easter Egg Hunt this year as they have previously done. It will be on Sunday 26 March at 2pm. They also requested if they could be granted permission to do this annually.

196 LETTER REGARDING ANIMALS IN TRAVELLING CIRCUSES

The Parish Council has received a letter asking for the Council to ban animal circuses from Sawston.

<u>It was PROPOSED by Councillor W N Reid and Seconded by Councillor K J L Cooper to SUSPEND Standing Orders to allow the public to speak about this matter</u>

VOTE: 7 FOR : (UNANIMOUS)

A spokeswoman addressed the meeting about the petition the Parish Council has received regarding banning the animal circus and explained about the cruelty to wild animals like elephants, lions etc and asked if the Parish Council would make a policy to ban wild animals.

The Parish Council also received letters asking that the circus is not banned from the village.

A statement was read out from the Proprietor of the circus who explained he does not have wild animals; they have a small family of animals including Llamas, goats, ponies, ducks and dogs. These animals are well looked after and are on show to the public 24 hours a day and they are open for inspection.

Councillor K Cuffley thanked them for coming.

It was PROPOSED by Councillor K J L Cooper and SECONDED by Councillor Ms B Laxton to reinstate Standing Orders to allow the meeting to be continued

This was discussed and a couple of Councillors said there has been a lot of support for the circus within the village and on the local Facebook page, therefore it was *PROPOSED* by Councillor Ms B Laxton and *SECONDED* by Councillor W N Reid that the circus still visits Sawston but is assessed each time they request to visit Sawston.

The Clerk explained that Head Groundsman Mr A R Poole has requested a tow bar to be fitted to the works van. The Clerk had not received all the quotes in time.

It was **PROPOSED** by Councillor W N Reid and **SECONDED** by Councillor R M Richmond that a tow bar is purchased and fitted under Chairman's Actions provided the cost is no more than £500 to eliminate waiting another month until the next Full Parish Meeting.

198 SHREDDER FOR TREE WORK

The Clerk explained that the SCDC Trees Officer had visited Sawston and had advised some tree work to be done. Mr A R Poole Head Groundsman is able to do the majority of the work but would need to hire a shredder; he would then be able to use the bark around the village.

- £160 per day + £60 to deliver
- £150 per day + £42 to deliver
- £220 per day + £60 to deliver
- £310 for 5 days + £42 to deliver

Mr A R Poole's preference would be to hire the shredder for the 5 days as there are more areas he will be able to tidy up around the village within this time.
